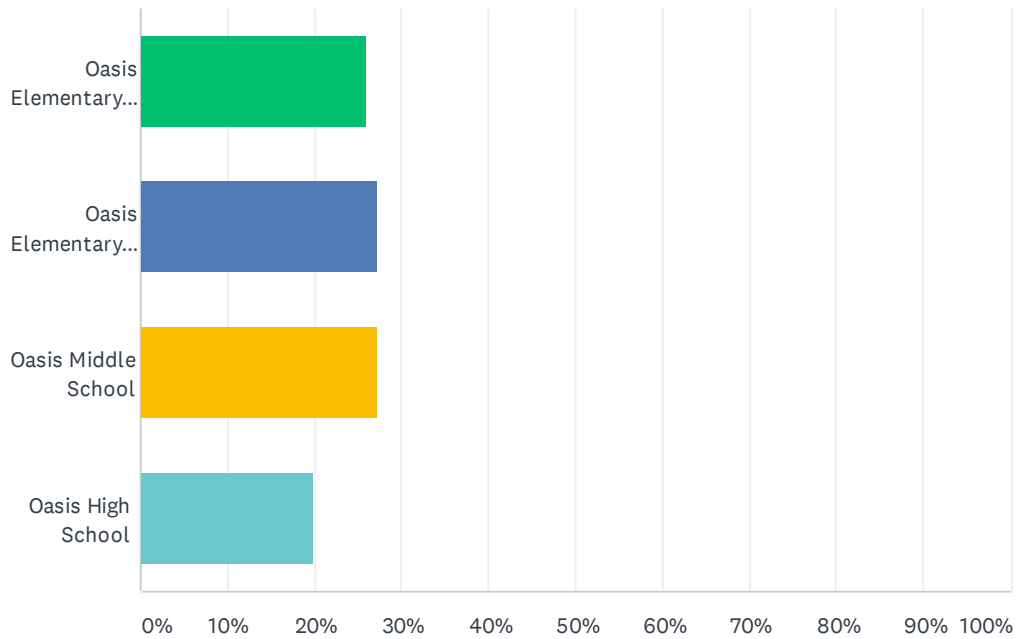


Q1 During the School Year 2020-2021, my child will attend the following school:

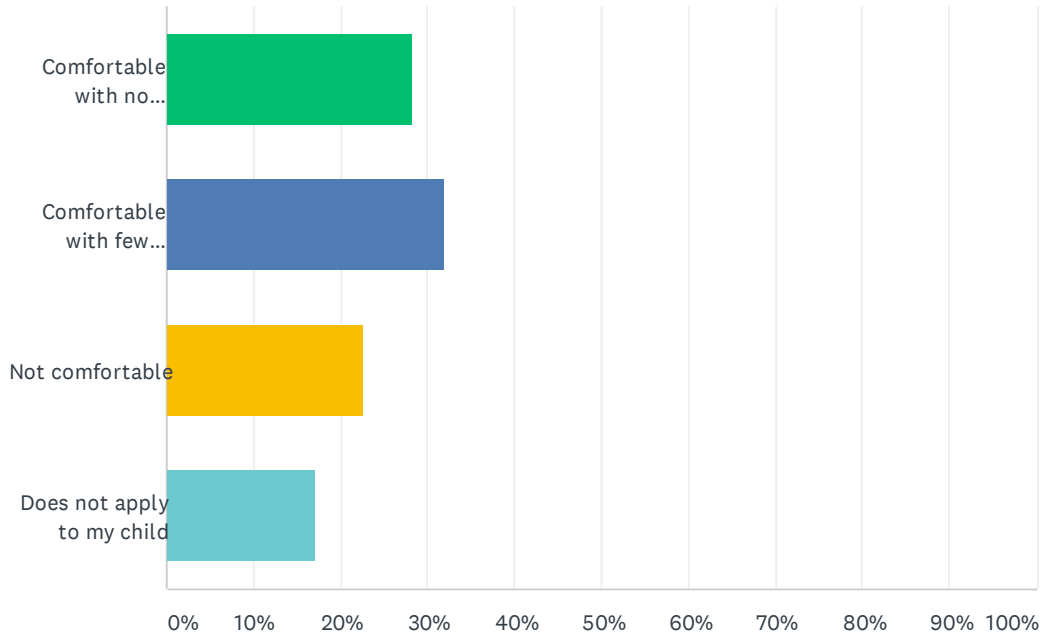

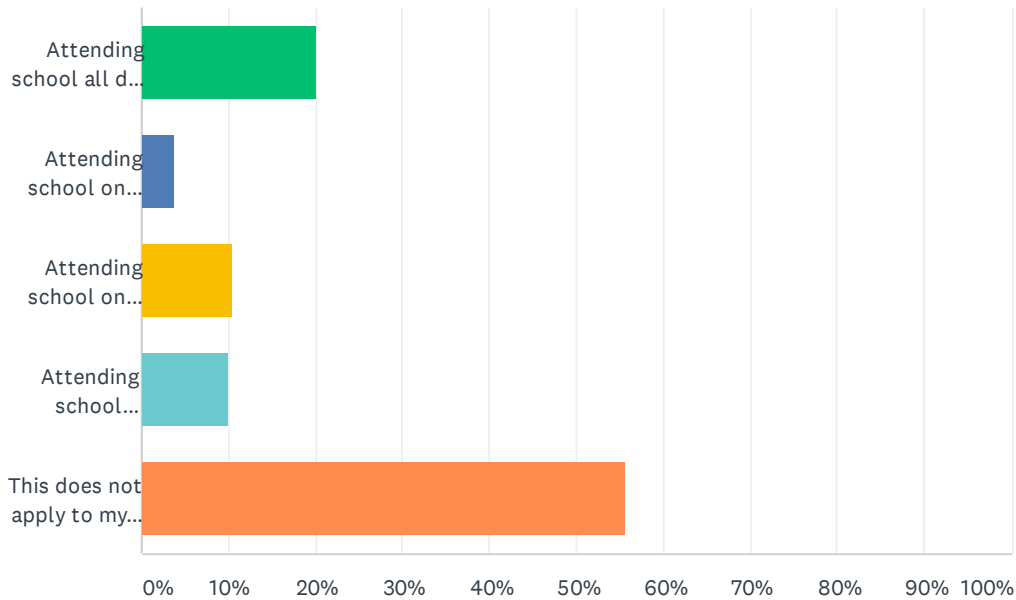

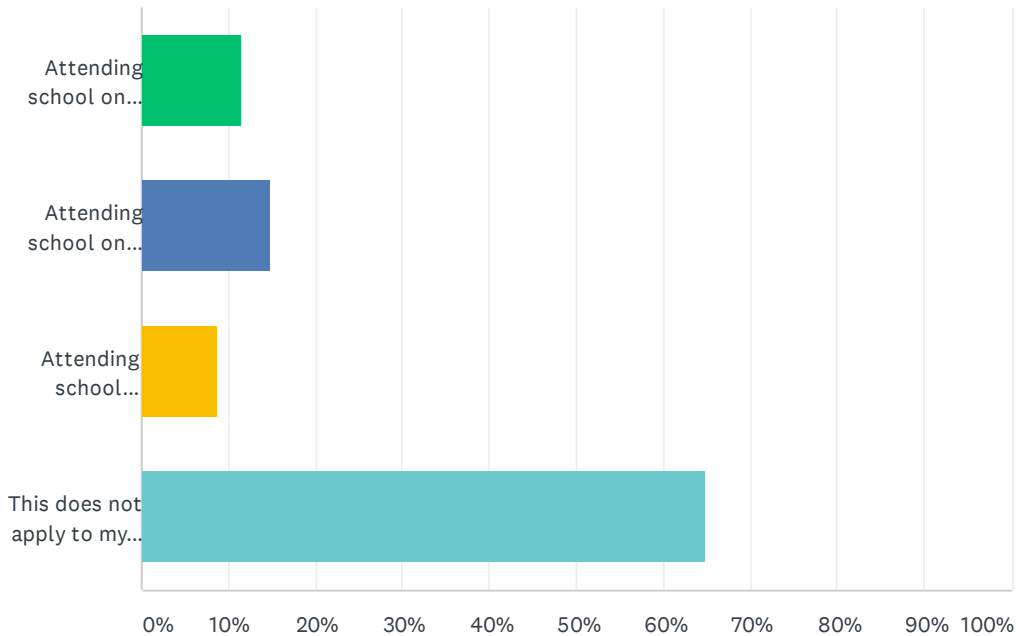

Q4 Modifications will be needed to reopen schools in grades 9 through 12 to meet required guidelines for social distancing. If given a choice, which option would you prefer?

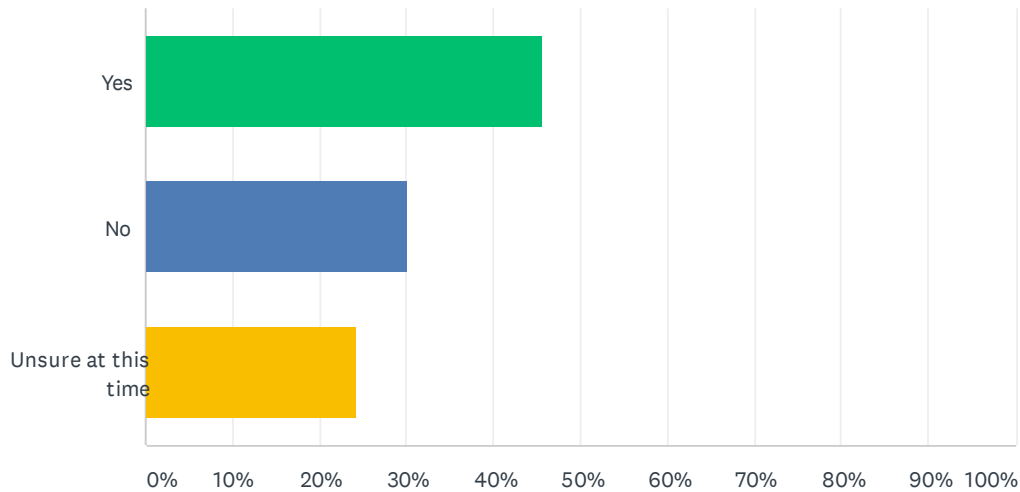

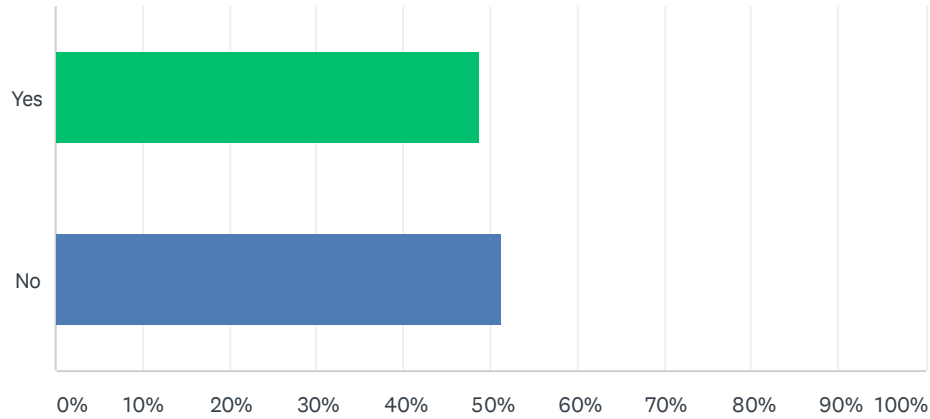

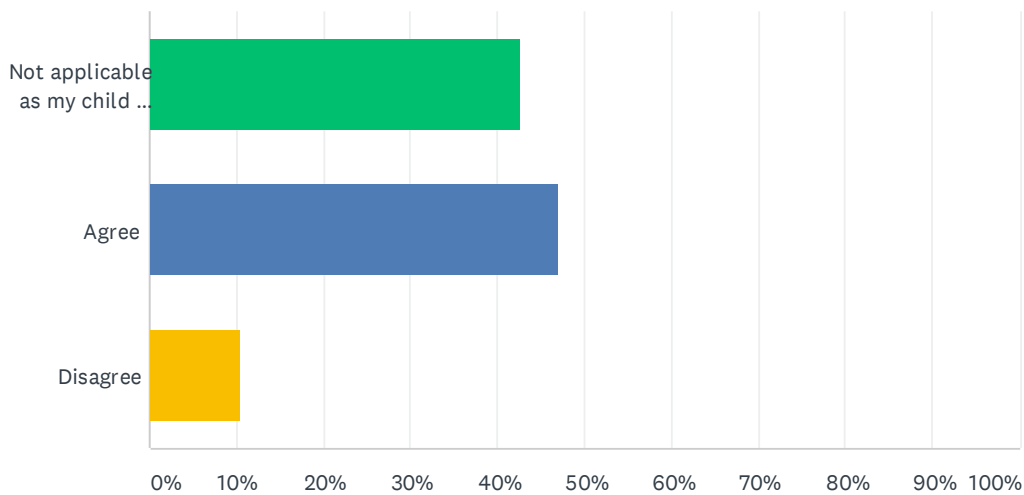
